Tamarac Village Community Development District (CDD) is located in the City of Tamarac, Broward County, Florida in Section 8, Township 49 South, Range 41 East. The Tamarac Village project generally consists of the land on the north and south sides of NW 57th Street, between NW 94th Avenue and NW 88th Avenue (a/k/a Pine Island Road) and includes both developed and vacant properties.
